UNDER FOUNDING ARTISTIC DIRECTOR, JAMES CANFIELD, A FORMER PRINCIPAL DANCER WITH THE JOFFREY BALLET, OBT DEVELOPED A UNIQUE REPERTOIRE AND DISTINCTIVE STYLE. WITH A FIRM FOUNDATION IN CLASSICAL TECHNIQUE, THE COMPANY'S DANCE INVENTORY GREW TO COMPRISE OVER 80 BALLETS INCLUDING EVENING-LENGTH CLASSICS, 20TH-CENTURY MASTERPIECES AND INNOVATIVE CONTEMPORARY WORKS. NAMED "BEST BALLET SCHOOL" (PORTLAND MONTHLY MAGAZINE, 2006), SOBT SEEKS TO ENSURE THAT ALL STUDENTS ACHIEVE THEIR FULL POTENTIAL AND GAIN A LASTING APPRECIATION OF THE ARTS, REGARDLESS OF WHETHER THEY CHOOSE TO PURSUE A PROFESSIONAL CAREER IN DANCE.
